## Human Trafficking of Minors 1/1/2015-12/31/2015


Between January 1, 2015 and December 31, 2015, the NHTRC hotline received reports of 5,545 potential human trafficking cases in the United States. **1,630** of these cases (29.4%) involved minor victims. The NHTRC defines a minor as an individual under 18 years of age. The following report is based on these cases.
